Dear Fellow Numismatist:

The **Maryland State Numismatic Association**, Inc. will be hosting exhibits at the Baltimore Coin and Currency Expo on March 27–30, 2014. The site will be the **Baltimore Convention Center**, located at One West Pratt Street, Baltimore, Maryland.

Exhibits may be set up on Friday, March 28th, 9:00 A. M. to 6:00 P. M. and Saturday, March 29th, 9:00 A.M. to 11:00 A.M. Exhibits must remain in place for viewing until 12:00 P. M. on Sunday, March 30th at which time they may be removed.

There will be two classifications of exhibits this year: Junior (exhibitors under 18) and Senior. Open judging will be used (no categories) to allow all exhibits to be in maximum competition with each other. The awards will include a Best of Show Award, Master and Superior. Appreciation awards will be given to all other exhibitors who display exhibits. Collectors may enter more than one exhibit, but will be **entitled to receive only ONE award**.

Enclosed is an exhibit application, which may be duplicated. In order for MARYLAND STATE to have the proper number of awards and to ensure availability of space for your exhibits, we request that all entries be returned no later than **February 15, 2014**. Requests for exhibit space received after that date will be honored if space and cases are available. If you should enter more than one exhibit, please use a separate exhibit application for each entry.

1. Exhibit applications should be received no later than February 15, 2014. Applications received after that date will be accepted if space and cases are available.
2. All exhibits are to be in place by 11:00 A.M. on Saturday, March 29, 2014 and are not to be removed without permission of the Exhibit Chairman prior to 12:00 P.M. on Sunday, March 30, 2014.
3. It is understood that your exhibit case(s) will be opened **ONLY** in your presence.
4. All keys are to be retained by the Exhibit chairman.
5. All materials in a display must be the exclusive property of the exhibitor.
6. Any material in a display that is not genuine must be so identified.
7. The name or identity of exhibitors shall not appear on exhibits.
8. No exhibit shall contain advertising for items that are for sale.
9. The right is reserved to restrict material outside of the exhibit case(s), which might distract attention from other exhibits.
10. The maximum number of cases per single exhibit is six (6). If more than one exhibit is entered by a single exhibitor there will be a maximum of ten (10) cases total.

## EXHIBIT AGREEMENT

**I.** That the party of the first part will provide security guards for the Bourse and Exhibit areas during the period of the show, and the presence of the security guards is provided as a convenience only and is not intended to be an expressed or implied warranty of guarantee against any loss or injury whatsoever.

**II.** That the party of the second part hereby remits, releases and forever discharges the party of the first part, its officers, committees, member clubs, host clubs, members and employees either in their official corporate capacity, or in their individual or personnel capacity of and from all manner of actions, causes of actions, suits, proceedings, debts, contracts, judgments, damages, claims, and any loss, theft or damage of any kind which may occur to its possessions and exhibits howsoever sustained either directly or indirectly in connection with said convention and show including but not limited to the Bourse-Exhibit area or other convention space, and the street area near the Baltimore Convention Center and that the party of the first part, its officers, committees, club members, host clubs, or employees, may plead this release in bar of any claim demand, or cause of action instituted by the party of the second part.

**III.** That the party of the second part does, by this instrument, covenant with the said party of the first part to forever refrain from instituting or in any way aiding any claim, demand, action or cause of action, for damages, as a result of any loss or theft to the party of the second part during the said convention and show.
